**NOTICE IS HEREBY GIVEN** that the City of Sammamish received an application on June 8, 2017 requesting a Shoreline Exemption Permit (SEL) and SEPA for a normal maintenance and repair of an existing dock. The repair work includes replacing the worn decking with ThruFlow grated decking, replace with framed wooden platforms in the same footprint with ACZA frame platform secured with 6" steel piles. The subject property is located in the R-4 zone and in close proximity to Lake Sammamish which is a Shoreline of Statewide Significance. This parcel is located within the Lake Sammamish Shoreline Residential Environment Designation.

In accordance with SMC 20.05.060, on June 26, 2017 the City issued this Notice of Application by the following means: mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper.
